# Group Agreements

- **Speak your truth:** Say what is in your heart, trusting that your voice will be heard, and your contribution respected. Be aware that the impact of your words on others may be very different from your intent.
- **When things get difficult, turn to wonder:** If you find yourself disagreeing with another, becoming judgmental, or experiencing challenging emotions, try turning to wonder: "I wonder what she is thinking?" "I wonder what brought him to this place?" "I wonder what they are feeling right now?" "I wonder what my reaction teaches me about myself."
- **Identify assumptions and suspend judgment:** Our assumptions and judgments are usually invisible to us, yet they undergird our worldview. By identifying our assumptions, we can then set them aside and open our viewpoints to greater possibilities.

The CoC anticipates several funding opportunities this summer. Local competition deadlines will be released soon.

## **MSHDA ESG (amount available pending)**

- Exhibit 1 released - April 24th
- Exhibit 1 due – June 5<sup>th</sup>
- NOFA released – June 8th
- Application due – July 31st

## **HUD CoC (Amounts available pending)**

- Estimated NOFO Release – June 1st
- Estimated Application due date – August 26th

## **CoC Builds (\$100 million, 10 awards:\$1M-\$4M)**

- Estimated NOFO release – June 17th
- Estimated Application Due Date – August 16th

## **Youth Homelessness NOFO (\$197 million, 76 awards: \$500,000 - \$15M)**

- Two separate sources of funding:
  - Youth Homeless System Improvement (YHSI)
  - Youth Homeless Demonstration Project(YHDP)
- Estimated NOFO release – May 2026
- Estimated Application Due Date: July 29th

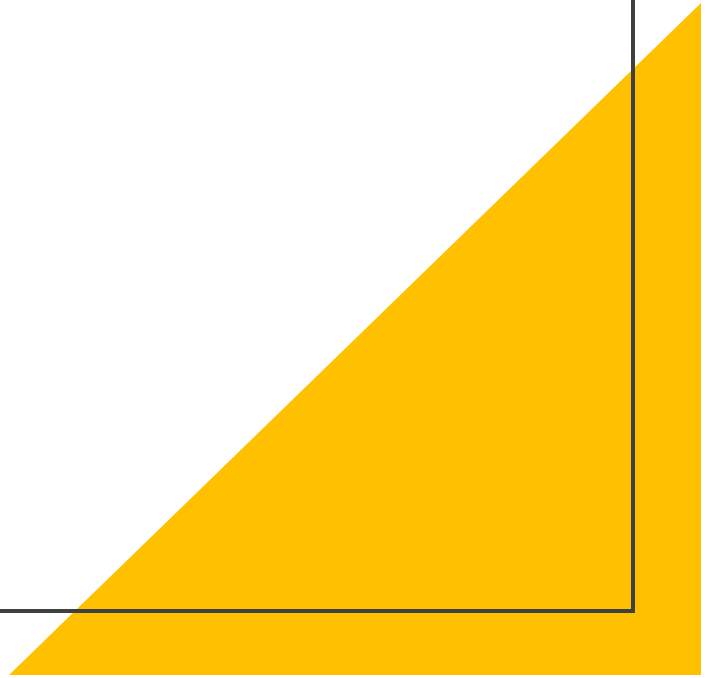

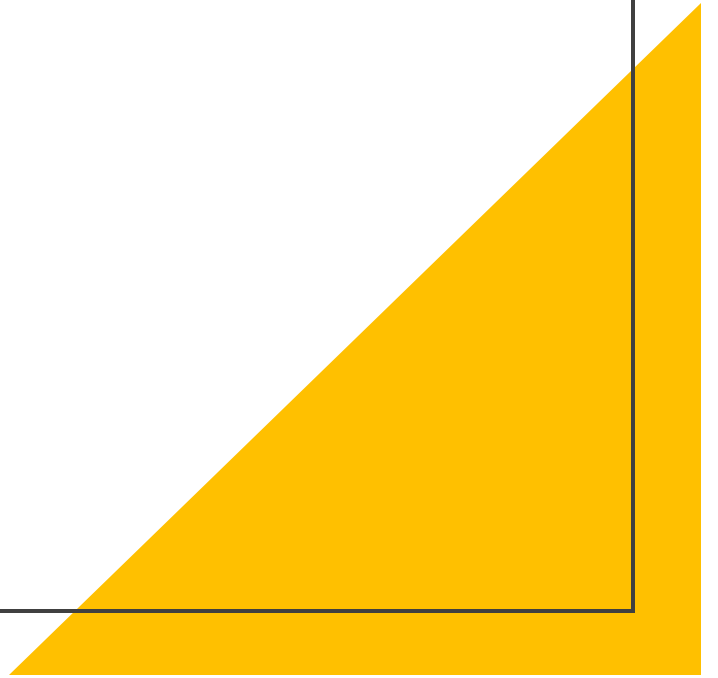
